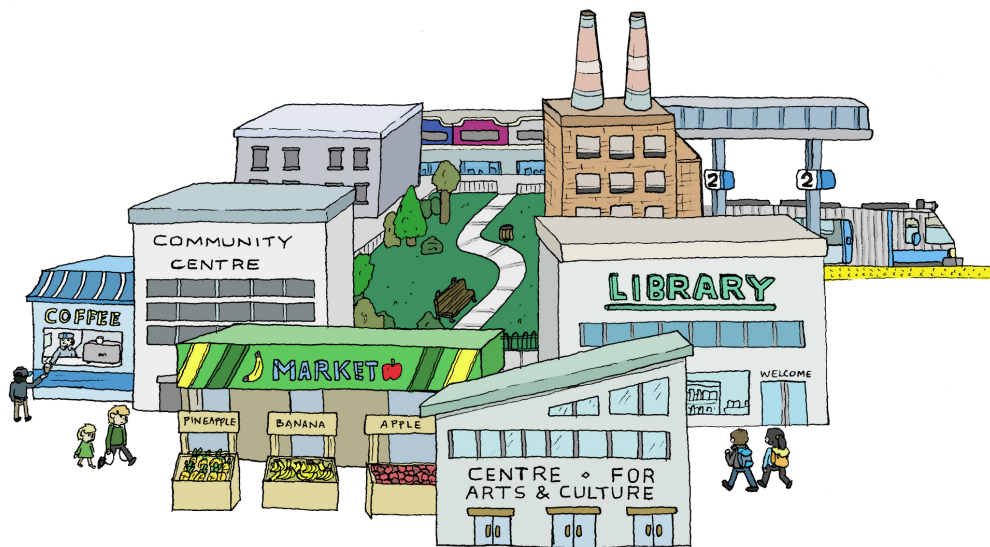

Our consultations focus on:

Context - We provide children with a clear understanding of the context in which they are working and the contribution they are being asked to make.

Creativity - We support children to think freely and openly about their responses, enabling them to contribute creatively and work through a wide range of original ideas.

Clarity - The framework we provide to children helps them craft responses in ways that are clear to an external audience, with specific and actionable recommendations.

Working With You

Our consultations are affordable, adaptable and can be delivered to your timeline. We can help engage children and young people at festivals and events, site activations, community spaces and through a range of engagement programs.

Delivery

Our workshops deliver clear and actionable outputs which:

- Engage children in a creative process that captures and distills their original and relevant responses.
- Ensure that every child can contribute meaningfully to the process.
- Conduct meaningful, equitable and inclusive engagement.
- Provide clients with clear data that can be used in reporting, consultation and community development.

- A report prepared by 100 Story Building analysing and synthesising children's responses.
- Metadata, including images, verbal quotes from children and young people, and planning and brainstorming documents.

Other outputs can include:

- Video and/or audio responses from children sharing their feedback and ideas.
- Event and activation design to bring some 100 Story Building magic to your community events.
- Ongoing facilitation to implement and action children's ideas within the community.
